

STATUTES OF THE FOUNDATION

"SH.K.B.SH"

" PRISON FELLOWSHIP ALBANIA "

ARTICLE 1

NAME AND LEGAL STATUS OF THE FOUNDATION

Foundation "**PRISON FELLOWSHIP ALBANIA**" is a non-profit, non-governmental organization, established based on the current provisions of the Albanian Civil Code and Law 8788, dt. 07.05.2001 "On Non-Profit Organizations". The foundation will act in accordance with the current Albanian laws, including also international pacts or conventions to which the Albanian state is a party.

The founders of this foundation are: David Wheeler, Femi Sufaj, David Rouquette, Jean Francois Lardy and Matthew Wilson.

ARTICLE 2

APPOINTMENT AND SEAT

This Foundation is called "**PRISON FELLOWSHIP ALBANIA**" and the abbreviated name is "SH.K.B.SH"

This Foundation will have its symbol and seal.

FOUNDATION'S HEADQUARTERS will be at the address in Tirana at "A. Kullurjoti" No. 6. He can create his branches and subsidiaries inside and outside the country. The creation of a branch or subsidiary is done by decision of the Board of Directors.

ARTICLE 3

THE FOUNDERS

The founders of this foundation are: David Wheeler, Femi Sufaj, David Rouquette, Jean Francois Lardy, Matthew Wilson as physical persons.

ARTICLE 4

DURATION

The duration of the Foundation's activity is unlimited. It will be conditioned by the achievement of the Foundation's goal.

ARTICLE 5

PURPOSE OF THE FOUNDATION

The goals of the "SH.K.B.SH" Foundation "PRISON FELLOWSHIP ALBANIA" are based on Christian principles and respect for basic human rights and freedoms.

Its purpose is:

- 1.1.** To help prisoners to develop their individual potential.
- 1.2.** To minimize the negative effects that deprivation of freedom brings, especially to young men and women.
- 1.3.** To help prisoners to successfully cope with their return to society and reintegration as normal citizens.

ARTICLE 6

AREAS OF ACTIVITY OF THE FOUNDATION

In order to achieve its goals, the "SH.K.B.SH" Foundation will develop its activity in different spheres, specifically

- 2.1** In help for the spiritual and physical development of prisoners
- 2.2.** In psycho-social and medical assistance for their rehabilitation and reintegration.
- 2.3** In help to prepare the prisoner for reintegration into society through
 - a. education, Bible study, Christian services, personal visits, libraries, professional courses, learning foreign languages, etc.
 - b. Further employment, through greenhouses, crafts, construction, etc.
 - c. Entertainment through sports, art, etc.
 - d. The connection of prisoners with family and civil society.
- 2.4** of assistance to improve the living conditions of prisoners.
- 2.5** Cooperation with governmental and non-governmental institutions for the reintegration of prisoners after release.
- 2.6** Assistance for the qualification and improvement of prison staff conditions.

In order to achieve its goals, the Foundation may use any other means that is considered a legal activity, which is not prohibited by Albanian law and which serves the achievement of the Foundation's goal. It will develop its activity in all prisons of Albania and outside it, as well as in detention centers.

ARTICLE 7

BRANCHES

In exercising its activity, the Foundation may open branches or representative offices anywhere, inside or outside the country, by decision of the Board of Directors of the Foundation.

ARTICLE 8
SOURCES OF INCOME AND USE

The sources of income will consist of funds, grants and donations provided by private or public entities, domestic or foreign, with the exception of those given for illegal purposes or provided through illegal sources. The Foundation's source of income will also be its economic activity, which is not its primary activity and which is consistent with the Foundation's purpose. The foundation has the right to carry out fundraising activities, to use them to fulfill its goals or to support the goals and activities of other non-profit organizations. The expenses of the Foundation will be made only for the realization of its purpose and for the direction and activity provided for in the act of establishment and the Statute of the foundation. The foundation will start its activity with a fund of 100,000 LEK.

No form of profit distribution, or material and financial benefit, from the income and profits of "SH.K.B.SH" is allowed by the persons who are subject to the statute and the act of establishment, except for obligations in the form of payments, salaries, rewards and compensations derived from the employment contract or other contracts similar to it, or to cover the expenses incurred by order and for the account of "SH.K.B.SH".

ARTICLE 9
STRUCTURE OF THE FOUNDATION

The structure of the Foundation consists of the Board of Directors of the Foundation, the Executive Director of the Foundation and the employees of the administration.

ARTICLE 10
BOARD OF DIRECTORS OF THE FOUNDATION

The Board of Directors of the Foundation consists of members who may not necessarily be Albanian. They are appointed with this task by the founders and are not employees of the Foundation.

- The Board of Directors of the Foundation meets at least once a year.
- Decides on the change of the statute and the object of activity.
- Defines the areas and programs of activity of "SH.K.B.SH" and its branches.
- Supervises and regularly controls the implementation of the foundation's programs.
- Examines economic, financial and administrative matters.
- Approves the most important acts regarding the budget of "SH.K.B.SH" and expenses.
- Issue norms for regulating the activity, organization and organizational structure of "SH.K.B.SH".
- Appoints and dismisses the Executive Director.

- Make a decision on the distribution, merger or transformation of "SH.K.B.SH" into an organization of another form.
- Decides on the creation of branches or subsidiaries in the districts or outside the country.
- Creates special committees, according to the need presented by the Executive Director.
- Decides on the development of economic activity by "SH.K.B.SH" according to the law, with the aim of generating income.
- Approves fundraising activities, according to Article 37 of Law 8788 dated 07.05.2001 "On non-profit organizations".
- Every year the Board of Directors elects its chairman.
- Appoints the liquidators and examines the report of the liquidators.
- Decides on the transfer of assets to other entities in case of distribution of "SH.K.B.SH"
- The meetings of the Board of Directors are valid when they are attended by no less than 2/3 of the eligible number of members. The decisions of the Board of Directors are taken with the vote in favor of 2/3 of the total number of members present in this body.

The first members of the Board of Directors of the Foundation are:

1. DAVID WHEELER - Engineer
2. FEMI SUFAJ - social worker
3. DAVID ROUQUETTE - pastor
4. MATTHEW WILSON - pastor

ARTICLE 11

EXECUTIVE DIRECTOR OF THE FOUNDATION.

- The Executive Director of "SH.K.B.SH" has all the competences necessary for the administration of the daily activity of "SH.K.B.SH" and the branches in districts or subsidiaries, in accordance with the statute, the decisions of the Board of Directors and of the legislation in force.
- The Foundation's Executive Director is appointed and dismissed by the Foundation's Board of Directors.
- The Executive Director of "SH.K.B.SH" reports and gives account to the Board of Directors as often as required.
- The Executive Director of the Foundation is an individual body.
- The Executive Director of the Foundation is responsible for the administration of the daily activity of the Foundation.
- The Executive Director of the Foundation is responsible for all programs established by the Board of Directors of the Foundation.
- The Executive Director of the Foundation represents the Foundation in relation to third parties, having the right to delegate this right.
- The Executive Director of the Foundation employs the entire administration of the Foundation.

- The Executive Director of the Foundation may request meetings outside of the Board of Directors of the Foundation.
- He is dismissed from office by the Board of Directors of the Foundation when he does not perform the duties assigned by this statute or performs prohibited activities.

The Executive Director of the Foundation will be Mr. Jean Francois Lardy, the son of the son of Camille, born on 13.06.1966, residing at Rr" Ali Demi" P.276, shk. 1, floor 5. Tirana.

ARTICLE 12

PROPERTY ADMINISTRATION CRITERIA

The administration of the property of "SH.K.B.SH" is done in accordance with the legislation in force.

For all economic and financial activities, a regular balance is kept, which is approved by the Board of Directors within the first quarter of the following year.

"SH.K.B.SH" has its own bank accounts, which are opened and operated according to the orders of the Executive Director.

The Board of Directors and potential donors can at any time request explanations about the financial situation of the organization and the Executive Director and the staff of "SH.K.B.SH" provide them within an optimal period and if requested, they are accompanied by photocopies of the respective documentation.

ARTICLE 13

APPROVAL OF INTERNAL RULES

The internal regulations of "SH.K.B.SH", which determine the operating norms of the different sectors of this Foundation, relations with clients, etc., are approved by the Board of Directors. They are drawn up by the staff in accordance with the founding act and the statute of "SH.K.B.SH".

ARTICLE 14

TRANSFORMATION, MERGER AND DISTRIBUTION OF THE FOUNDATION

*The transformation of "SH.K.B.SH" into any other non-profit entity, merger or re-division is done by the decision of the Board of Directors, always based on the interest of its activity and to provide services for the good of the public, always applying the requirements of the Civil Code, of the law "On non-profit organizations" and the law "On registration of non-profit organizations".

A transformed Foundation is considered dissolved at the time of registration in the Court of the new entity.

ARTICLE 15

LIQUIDATION

When the distribution of the Foundation "PRISON FELLOWSHIP ALBANIA" is decided, the Board of Directors appoints one or several liquidators. These have the authority and responsibility over the assets, property and representation of "SH.K.B.SH" from the date of their appointment and until the end of the liquidation.

The liquidators carry out their activities based on Article 47 of the "Non-profit" law and in accordance with other legal provisions in force.

When the distribution of "SH.K.B.SH" is decided by the free will of the Board of Directors, this body also approves the final report of the liquidator and requests from the competent Court c, the registration of "SH.K.B.SH". In case the final report of the liquidators is not approved by the Board of Directors, that report is reviewed by the court in presence of the parties.

ARTICLE 16

DESTINATION OF PROPERTY AFTER COMPLETION OF THE FOUNDATION

In the event that, for reasons provided in this statute, or for other reasons provided by law, "SH.K.B.SH" ceases its activity, all its movable and immovable assets pass to its founders. If they are not accepted by the founders, by decision of the Board of Directors, they are donated to a non-profit organization that carries out activities related to our "SH.K.B.SH".

In no case can these assets be distributed in the interest of natural or legal persons who develop profitable activities, nor can they be divided between the employees of "SH.K.B.SH" and the persons who take part in its management bodies.

ARTICLE 17

STAMPS

The Foundation will have its own seal with this content: Foundation "PRISON FELLOWSHIP ALBANIA" which will be the symbol of the Foundation and which will accompany all the documentation that will come out of it.

ARTICLE 18

DISPUTE RESOLUTION

Disagreements between the decision-making and executive bodies or between them and the employees are resolved amicably and in accordance with the Statute and the rules of the Foundation, otherwise the case is settled by the Court.

For everything that is not stated in this statute, the provisions apply of the Albania Non-Profit Civil Code in force, and law 8788, dt. 5.7.2001 "For Non-Profit Organizations". This statute is drawn up in four copies of the same value.
